

## **Millicom Terms of Use**

This website or application is made available by Millicom. When we use the terms Millicom, we or our in these Terms of Use, we are referring to Millicom International Cellular S.A. and/or its affiliates, including those operating under the “Tigo” and “Zantel” brand. Millicom owns and operates this website, the mobile version of this website, and any other sites that link to these Terms of Use. We refer to all of these as the “Site” in these Terms of Use.

The Site provides general information about our company and our telecommunication products and services available in the territories where Millicom operates. We encourage you to read these Terms of Use carefully. Your use of the Site will be deemed your acceptance and agreement with these Terms of Use. If you do not agree with these Terms of Use, you should not use the Site.

You also consent to contract electronically with us, and that the electronic version of these Terms of Use will have the same legal effect as a written agreement.

### **1. These Terms of Use May Change**

We may update these Terms of Use without providing advance notice to you. We will publish these updates with a notice of changes on our Site for you to read. If you continue using the Site after such updates are published, you agree to those changes.
