*To participate at the EGM, SDR holders having registered their SDRs in the name of a broker or nominee must temporarily re-register the SDRs in their own name in the records maintained by Euroclear Sweden AB. SDR holders wishing to re-register must inform their broker/nominee well in advance of the Record Date so that they appear on the records maintained by Euroclear Sweden AB at **24.00 CET on January 10, 2022**. Please note that SDR holders who have not re-registered their SDRs with Euroclear Sweden AB by **January 10, 2022** will not be eligible to participate in the EGM.*
